- 3) A person is selected and can be removed by the President or Core Committee without notice or giving reason for misconduct, misbehaviour, indiscipline.
- 4) The member is willing to work and obey the President and core Committee.
- 5) The member will give his best effort to fulfil and support aims & objectives and task assigned to him or her.
- 6) Member should attend the general meetings and participate fully and have to give written application for being absent, 3 days before the meeting.
- 7) If the member concerned is included in the executive committee, the very member has to be present in every monthly committee meeting notified earlier.
  - a) If the executive member is not present in three consecutive monthly meetings his / her position in the committee will be debarred.
  - b) The debarred committee person may gain his / her position in case, the person is able to show a valid cause to the Governing body / house and in that case after the acknowledgement of the majority committee members President and Secretary may approve his application for the same.
  - c) The executive committee member has to attend any special meeting if the President or Secretary arrange the same if required other than the monthly meeting.
- 8) **The President has the supreme power to form or diffuse a core committee.**
- 9) **It is duty of a member to obey and give due respect to the President and the core committee.**
- 10) **Membership Fee should be paid with Application Form on Rejection of Application the Membership fee will be refund in a month.**
